EVENT DETAILS

- 1. Players start with 25,000 in tournament chips.
- 2. Day 1, levels change every 25 minutes. Day 2, levels change every 40 minutes.
- 3. Late registration and re-entries are allowed until the start of level 11. No Refunds.
- 4. Re-entries take priority over alternates. Alternates have 10 minutes to re-enter.
- 5. A single ante will be paid from the Big Blind for the entire table. The ante is posted prior to the Big Blind.
- 6. Day 2 is Sunday, May 26th @ 11:15 AM and will play to a winner.
- 7. 1 in 8 entries will be in the money. Day 1's conclude once 12.5% of the field remains.
- 8. Players are permitted to register and play multiple Day 1 flights.
- 9. Players qualifying for Day 2 may play another Day 1 flight in an attempt to better their chip count.
