GENERAL RULES

1. No purchase necessary.
2. Must be 21 years of age or older to participate.
3. Must be a member of Live! Rewards Club and membership is free.
4. Must be present to win.
5. Prizes are non-transferable.
6. May only participate one (1) time during the promotion
7. Participants must earn a minimum monthly tier credit level to maintain their tier
8. Management reserves the right to downgrade anyone who does not meet the monthly point criteria
9. Monthly points use for the minimum criteria do not carry over.
10. Patrons must earn the published annual point levels in 2022 to qualify for tiering in 2023.
7. Winners are responsible for any United States federal, state, or local taxes and/or government fees that may be imposed in connection with the acceptance of the prize.
